Recycling and Solid Waste Programs	Results
<p>Materials Recycling Facility (MRF) Operations</p> <p>Recycling Grant</p> <p>Education</p>	<ul style="list-style-type: none"> ▪ Processed 21,022 tons of residential recyclables ▪ Replaced original baler infeed conveyors ▪ Completed RFP process and selection of contractor for new 5-year agreement to operate MRF ▪ 84,240 households received weekly recyclables collection ▪ Distributed \$500,000 in recycling dividends to 25 participating communities ▪ Provided documentation to the DNR on recycling costs and programs in order to receive a \$1.13 million grant ▪ Developed new brochure promoting MRF Tours and distributed to schools and youth organizations ▪ Updated questions and answers for Wise Tree of Recycling display ▪ Educated 1,145 MRF visitors – a 23% increase over last year
<p>Education and Outreach</p>	<ul style="list-style-type: none"> ▪ Presentations reached 532 students and 138 adults ▪ Recycling and Waste Reduction Newspaper mailed to 150,000 county households ▪ Over 300 newsletter readers completed opinion surveys and entered a drawing for 5 home compost bins ▪ Mailed out and completed compost bin survey ▪ 117,000 tax mailing inserts promoted computer recycling and disposal options for special wastes ▪ “History of Trash”, 3-layer puzzle, attracted people to the recycling & waste reduction display at County Fair ▪ Updated recycling and waste reduction fact sheets, posters and brochures and added them to the website
<p>Business/In-house Reduction & Recycling</p>	<ul style="list-style-type: none"> ▪ Conducted 59 business inspections in 18 communities, including 27 waste assessments of schools and county parks ▪ Initiated in-house Pollution Prevention (P2) Team ▪ Collected 174 tons of paper/cardboard, 14 tons of commingled materials, and about 1 ton of polystyrene at County buildings ▪ Partnered with UW-Extension Solid and Hazardous Waste Education Center and Wisconsin Focus on Energy to conduct waste assessments of four School District of Waukesha schools

Waste Reduction Coalition	<ul style="list-style-type: none"> ▪ Published annual Green Pages in cooperation with MJS ▪ Secured The Home Depot and Wisconsin Energy Corporation as sponsors ▪ Received a Wisconsin Environmental Education Board grant to expand Coalition programs to Jefferson County and Cedarburg area ▪ Awarded \$9,900 in scholarships to 24 area students ▪ Assisted in diverting kitchen grease and 1,200 pounds of cardboard from the 2001 Waukesha RiverFest ▪ Collected 5,300 soda/water bottles and 840 pounds of cardboard/paper for recycling at the County Fair and composted 500 pounds of food waste from 4-H Building
Household Hazardous Waste County Program Superior Emerald Park Program	<ul style="list-style-type: none"> ▪ Served a total of 4,756 households at county and SEPL sites, an increase of 22% over 2000 ▪ Collected a total of 242,468 pounds of hazardous material ▪ Included 2,907 households at the 2 county operated sites at a cost of \$42.23 per participating household ▪ Included 1,849 households at 6 satellite collection events and the Muskego site under the SEPL program at no cost to county
Agricultural/Business Clean Sweep Program	<ul style="list-style-type: none"> ▪ Received \$14,694 Dept. of Agriculture Trade and Consumer Protection (DATCP) grant to implement ongoing program in conjunction with HHW collection at Waukesha incinerator ▪ Developed targeted promotion to farmers, agricultural and small businesses through brochures, chamber of commerce newsletters and newspaper ads ▪ Served 23 farms and businesses ▪ Collected 5,570 pounds of hazardous waste
Miscellaneous Computers Textiles Food Recovery Task Force	<ul style="list-style-type: none"> ▪ Managed collection of 31 tons of computers from the City of Waukesha and the City of Brookfield drop-off sites ▪ Due to poor markets, Goodwill discontinued textile recycling collection at the cities of Brookfield, Delafield, New Berlin, and Waukesha drop-off centers ▪ Prior to those closings, municipal sites collected a total of 47,900 pounds of textiles for recycling in 2001 ▪ Formalized Food Recovery Program of Waukesha County as a program of the Food Pantry of Waukesha
